As of the April Board of Director's Meeting; with paid membership to CFRW by March 31, 2023, there were 25 active clubs (with 10 or more members), for a total of 743 members.

As of August 10, 2023 we have 868 members.

Delegates for our Fall Convention are determined by club membership submitted and POSTMARKED on or before May 30th. Per CFRW Bylaws 10.3:

- A. Club delegates shall be apportioned on the number of members whose annual dues are received by the CFRW Treasurer postmarked on or before May 30 of the annual convention year.
- B. In addition to each clubs President, the club is entitled to an additional delegate.
- C. Each club is entitled to one additional delegate for each fifteen (15) members.
- D. Each club is entitled to as many alternates as delegates, alternates being ranked by club according to highest number of votes each received.
